REMEMBERANCES

Emil Carl Marty, the son of Herman Henry Marty and Amelia Sophia Von Fange Marty, was born May 3, 1906 on a farm in Lincoln County, Kansas. He departed this life Sunday, October 30, 1994 at the Ottawa County Hospital in Minneapolis,

Kansas, having reached the age of 88 years 5 month and 27 days.

He was united in marriage to Dorothy Lavergn Smith September 26, 1928 at Lincoln, Kansas. They moved to Culver, Kansas in 1935 from Beverly, Kansas.

Emil was well known throughout the area for his mechanical skills, operating a shop in Culver since moving there. He taught Vo-Tech students in his shop and became known as an authority on Model A Ford restoration. He also did custom harvesting in the 1950's.

He was preceded in death by a son, Lyle Marty, in 1967 and his wife Lavergn in 1987.

Survivors include a son, Harold Marty, of Watervliet, Michigan; a daughter, Dorothy Wildfong, of Culver; a brother, Edwin, of Salina; two sisters, Clara Leiker of Salina, and Alma Buck of Colorado Springs, Colorado; 7 grandchildren and 4 great-grandchildren.

The family suggests memorials to the Ottawa County Hospital, Minneapolis, Kansas.

Funeral Services were held at 10:00 a.m., November 3, 1994 at Shields Funeral Home in Mineapolis. The Reverend Helen Dent officiating. Organist Edna McCall. The east half of the north east quarter of Section thirty four (34), and the west half of the north west quarter of section (35) all in Township Eighteen (18), North range twelve (12) west of the third principal meridian.

situated in the County of Cass in the State of Illinois, hereby releasing and waiving all rights under and by virtue of the Homestead Exemption Laws of this State.

Beardstown in and for the said County, in State aforementioned, do hereby certify that Gottlieb Marty who is personally known to me to be the same person whose name is subscribed to the foregoing instrument, appeared before me this day in person and acknowledged that he signed sealed and delivered the said instrument as his free and voluntary act, for the uses and purposed therein set forth, including the release and waiver of the right of Homestead.
