1907 - 1994

**Charles Augustus Percival**, son of Charles Augustus and Lenah Cassell Percival, was born Nov. 3, 1907, at Beverly, Kansas. He died May 24, 1994 at the Rock County Memorial Hospital in Basset at the age of 86, following an automobile accident.

He attended school in Kansas and graduated from Tescott High School in 1923. He attended one year of college at Kansas State University.

He was united in marriage to Geneva Pauline Judd on Jan. 31, 1934, at Salina, Kansas. The union was blessed with five children and 59 years of marriage.

The family lived in Kansas where Charles was involved in the carpentry and hatchery business. He began farming in the early 1940's and he and the family moved to the Carelton area in 1957 where he farmed until his retirement in 1975. Upon his retirement from farming, the couple traveled and explored the United State, Canada and Mexico.



**DEED OF TRUST**

Gottlieb Marty  
To  
Conrad Mayreis

A.D. Filed for Record Feb. 21st 1881  
at 1 O'clock P.M.  
J.E. Downing Recorder

The Grantor Gottlieb Marty and Elizabeth Marty his wife of the County of Cass and State of Illinois for and in consideration of four thousand dollars, in hand paid, convey and warrant to Conrad Mayreis of the city of Beardstown, County of Cass and State of Illinois the following described real estate.

The east half of the north east quarter of Section thirty four (34) and the west half of the north west quarter of Section thirty five (35) all in township eighteen (18) north range twelve (12) west of the third principal meridian, situated in the County of Cass in the State of Illinois hereby releasing and waiving all rights under and by virtue of the Homestead Exemption Laws of this State.

Dated this third day of August A.D. 1880.
